Chart 1: Crimes on All DH Streets and Single-Family (May 2018-November 2024)

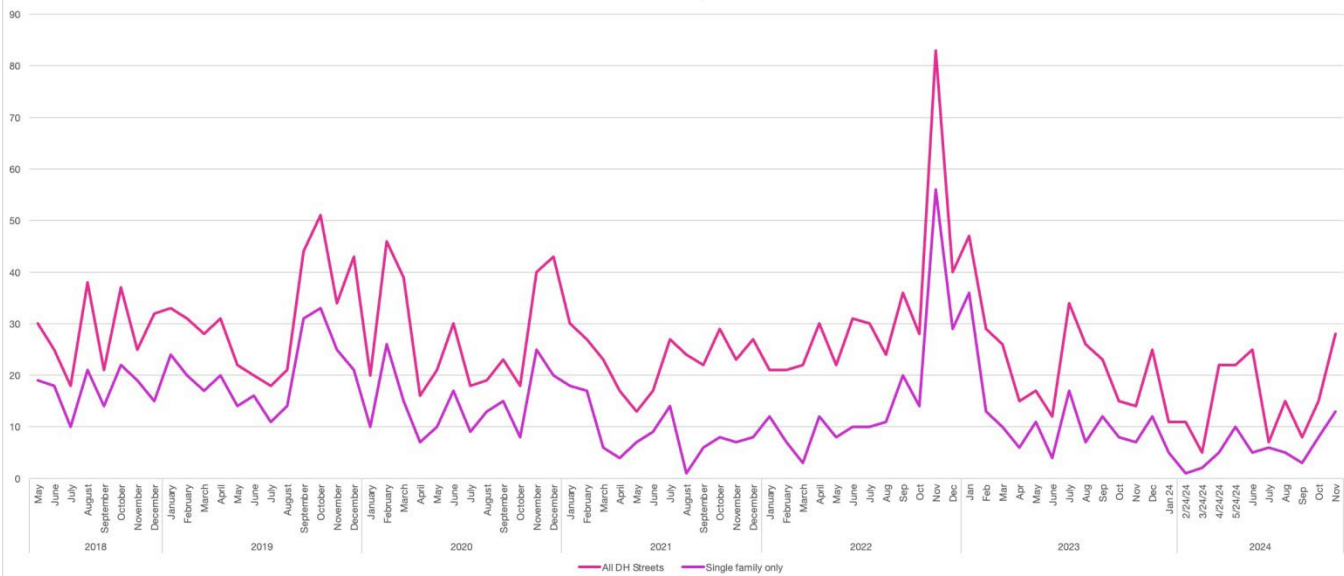
